Textbook: Conway, J.: A First Course in Analysis

Prerequisites: MA 2743 and MA 3053

Objective: Analysis is a broad area of mathematics. This is the first part in a two semester sequence. In this class we will focus on the theory of calculus on \mathbb{R} and rigorously prove all of the items taught in a calculus sequence. In the second semester we will focus on the theory of calculus in general metric spaces.
