**Objective:** This is the second semester of a year long course in functional analysis. The main tools were developed in the first semester. During this semester we will look at three different areas of functional analysis that heavily uses the tools from the first semester. In particular we will focus on the theory of unbounded operators, the theory of distribution spaces, the Fourier transform, and the theory of  $C^*$ -algebras.
