**Prerequisites:** Undergraduate real analysis

**Objective:** Real analysis is a broad area of mathematics. We will be focusing on the theory of measure and integration which has become an indispensable tool in remarkably diverse areas of mathematics. This is the first part in a two semester sequence. In this class we will focus on the theory of Lebesgue measure and integration on  $\mathbb{R}$  and in the second semester we will focus on general measure and integration over abstract measure spaces.

It will cover section 1.4, chapter 2, chapter 3, section 4.1 and section 4.2.

**Final Exam:** The final exam is **not** a comprehensive exam and will be held on **Monday, December 4<sup>th</sup>** in the usual class location at **8:00 - 11:00 am**. This date can **not** be modified, so make sure one's calendar is free. It will cover the remaining sections of chapter 4 and the corresponding sections from chapters 5, 6, 7, and 8.

Make-up exams must be taken within one week of the original date, and no make-ups may be taken after the final exam. Make-up exams are never easier than the original.
